## Section 4. First aid measures

### **Description of necessary first aid measures**

Eye contact

Inhalation

Remove victim to fresh air and keep at rest in a position comfortable for breathing. If not breathing, if breathing is irregular or if respiratory arrest occurs, provide artificial respiration or oxygen by trained personnel. #### Personal precautions, protective equipment and emergency procedures

## Section 6. Accidental release measures

### **Environmental precautions**

#### Methods and materials for containment and cleaning up

### Small spill

### Large spill

### **Precautions for safe handling**
